

Every day, Gill receives referrals for various unmet needs. Although many are the same, others are unique and just as critical to the families we serve. Recently, a case worker from the Women's Center referred a client to our office. This single mother is doing her best to raise a toddler and infant on her own. She relies on public transportation to take her to her meetings, job, and daycare for her children. Before turning to Gill, she did not have a stroller to help transport her children. She struggled to hold her infant and her toddler at the same time. After the referral to us. Gill was able to purchase a new double stroller to help her with her day to day activities. This will allow her to travel safely with her children.
